EDITORIAL

The rapid changes and increased complexity of today's world present new challenges and put new demands on our education system. Technology has changed the face of education by evolving newer concepts and techniques. Besides, teaching learning is no longer confined to the

geographical boundary of any country and thereby making education completely global. With the help of modern technological tools like Skype, teachers are able to connect with other teachers around the world and design different learning methods for their students. Students also can interact with their counterparts sitting in any part of the globe.

The latest trend in education system is Online Education provided by many universities. Twelve leading universities in the U.S. and Europe joined an internet platform created by two Stanford University scientists which provides online access to classes designed by academics at elite institutions. Harvard University has produced online courses and other forms of digital learning for several decades with the goal of making educational content available to a global audience. Harvard University has collaborated with MIT and is providing learning content online. Some Indian Universities like Jaipur National University are also providing interdisciplinary online programmes.

In a bid to encourage combined research activities, the All India Council of Technical Education (AICTE) has recently launched a portal where students across AICTE approved institutes will be able to upload their research projects. These projects will be in public domain and therefore will be accessible to Research Labs and even to industries. In this way if anybody is interested in doing research in a particular area, he/she can use the database to add further value to his/her project or can initiate combined research activities. AICTE has also launched a unique job portal in which faculties and students can create their profile on the portal. The job portal will be a huge database of students who are eligible for placements. At the same time around 12,000 industries under the Confederation of Indian Industries will be registered on the portal. Thus, AICTE portals will benefit both the industries and the students.

Looking at the changing educational scenario, Rajasthani Sammelan

is also set to launch Online Academy to be known as Kunjbihari S. Goyal Online Academy. Through online academy, lectures of well qualified lecturers will be available on the website and students will be able to study from the convenience of their

own home. Besides the student will be able to view the lecture again and again to clear his/her concept. The online academy will provide lectures of degree and post-graduate courses.

As the world has become a global village, in the true sense of the term, Student Exchange Programme is also becoming popular day by day. Many universities, schools and colleges are encouraging student exchange programmes for cultural as well as academic purposes. The exchange program provides the students with a window to the culture and customs of other countries. Therefore, encouraged by our President and management members, Mainadevi Bajaj International School organized the second student exchange programme in this academic year with Scheffel Gymnasium School, Bad-Sackingen, Germany.

For enrichment of knowledge of the faculty members, eminent scholars and dignitaries have been invited in R.S. Campus in the past few months. Along with reputed scholars from Indian Universities, many academicians from universities of Harvard and other universities of U.S.A. have visited our campus and have interacted with our faculty members and students. Such interactions have resulted in exchange of rich ideas and learning more about other cultures by all of us. Recently, eminent educationist Prof. Ali S. Asani, Chair of the Department of Near East Languages & Civilization, Harvard University was invited in R.S. Campus on 21st November, 2013. He was also accompanied by Dr. Kashyap Choksi, Senior Director of International Advancement, Harvard University

Shri Ramgopalji Ruia Founder Member, Rajasthani Sammelan

Shri Ramgopalji Ruia has been one of the founder members of Rajasthani Sammelan. He rendered his dedicated services for more than two decades to the formation of Rajasthani Sammelan followed by establishment of some of the institutions of Rajasthani Sammelan. Shri Ramgopalji Ruia as well as other founder members faced many



challenges in the earlier days of Rajasthani Sammelan when they had worked very hard to obtain land for the trust followed by construction of the school building of Sarvodaya Balika Vidyalaya, now known as Kudilal Govindram Seksaria Sarvodaya School. Shri Ramgopalji Ruia also provided his valuable contribution in drafting the first constitution of Rajasthani Sammelan along with other founder members which was signed on 20.09.1958. Earlier to that Rajasthani Sammelan had functioned as an unregistered body for about five years.

Shri Ramgopalji Ruia had been one of the office bearers of Rajasthani Sammelan for a long period as Hon. Secretary, Treasurer, Vice President and President and Trustee from 1950-51 to 1977-78. During his tenure, educational institutions of Sarvodaya Balika

Vidyalaya and Durgadevi Saraf Junior College were started by Rajasthani Sammelan. The community hall, Dhurmal Bajaj Bhavan was also inaugurated in his time by Shri Aditya Birla, the renowned industrialist at a glittering function organized by Rajasthani Sammelan. Under his leadership as President, the Silver Jubilee of Rajasthani Sammelan was also celebrated on 3rd July, 1976 at Birla Matoshree Sabagriha at a glittering function graced by famous industrialist and philanthropist, Dr. Ramnathji Podar as the Chief Guest.

Shri Ramgopalji Ruia belongs to a family of businessmen. He completed his graduation in 1948 from Sydenham

College, Mumbai and obtained gold medal in the subject of banking. Later, he joined his family business of exports. At the same time, he took great interest in girls' education and other philanthropic activities. Along with his devotion to education, he has been associated with following other trade and cultural organizations.

- Indian Oil and Produce Exporters Association as the Chairman. 2) Shree Rani Sati Mandir, Jhunjhunu, Rajasthan as Vice President.
- Shri Ram Gopalji Ruia is a very spiritual personal. He is associated



When and how did you get associated with Rajasthani Sammelan?

I was associated with Rajasthani Sammelan right from its inception. In fact, there were a group of Marwadi families staying in Malad (West) and in Malad (East). We used to meet at a particular house, mainly in the house of Shri Ghanshyamdasji Jalan or in our house for a get together during Holi and Diwali. Finally we decided that we must have a proper place for the meeting. Besides, in those days there was no girls' school in Malad or in western suburbs. So it was our desire to start a girls' school in Malad so that girls can

be educated up to S.S.C. level. At that time, Shri Vishwanathji Podar had obtained from Shri Kudilalji Seksaria, 4,000 sq. yds of land (part of the present area) to construct a school building which was then taken over by Rajasthani Sammelan as donation for construction of the school. Later on, Sarvodaya Balika Vidyalaya (now Kudilal Govindram Seksaria Sarvodaya School) was inaugurated in the year 1959.



When was the school inaugurated and who inaugurated the school?

Sarvodaya Balika Vidyalaya (now Kudilal Govindram Seksaria Sarvodaya

School) was inaugurated on 21st June, 1959 by the then Union Education Minister Dr. Kalulal Shreemali. The valuable




contributions made by founder members, late Shri Durgaduttji Thard, late Shri Ghanshyamdasji Jalan, late Shri Satyanarayanji Ganeriwal, late Shri Hariramji Saraf, late Shri Vishwanathji Podar and many others will be remembered.

What difficulties did you face during the early years of the educational endeavours of Rajasthani Sammelan?

It was a very difficult journey for us as collecting funds for the

construction of the school building was a real challenge. We did not have sufficient funds. Initially, we collected a sum of Rs. 51,000/- within our own group of workers and then an equal amount of Rs. 51,000/- was donated by Late Shri Brijmohanji Ruia. After that, we collected the required amounts in two or three phases to complete the school building. We also purchased some more land adjacent to the land donated by Shri Kudilalji Seksaria for future expansion as adjacent land would have been very difficult to get in future.



When was the first constitution of Rajasthani Sammelan framed and who were the signatories?

The first constitution was signed on 20th September, 1958 after our trust was registered. I was one of the signatories of the

constitution. Other signatories were Shri Ghanshyamdasji Jalan, Shri Kishorilalji Ruia, Shri Krishnaji Narsaria, Shri Biswanathji Seksaria, Shri Murlidharji Jalan, Shri Ratanlalji Saraf, Shri Hariramji Saraf, Shri Vishwanathji Podar, Shri Lalchandji Dalmia, Shri Gaurishankerji Nangalia, Shri Kashiprasadji Adukia and Shri Mahavirprasadji Kayal.


How do you rate the progress and development of Rajasthani Sammelan in its educational endeavour?

The progress has been excellent. We had started the school in the form of sowing a small plant which has now turned into a big shady tree with many branches. When we had started the school, it was our objective to start other institutions in future in such a way that girls can complete education up to graduation in this campus. But the present team has realized more than our dreams. Along with degree college they have started a management institute, a media college and many other facilities

in the campus. With changing times, co-education and English medium has also been introduced in the schools and colleges.

What is your message to the present team of Managing Committee of Rajasthani Sammelan?

We had started Sarvodaya Balika Vidyalaya with a social cause and therefore I feel that while introducing new courses and new institutions, more efforts should be taken to educate students coming







Enhancing RELIGIOUS LITERACY & Cultural competency in a globalized world

ajasthani Sammelan has from time to time invited eminent scholars and dignitaries in its educational campus to interact with management members, staff and students of all the institutions. Along with reputed scholars from Indian Universities, many eminent scholars from universities of Harvard, Oxford, Cambridge as well as other universities have visited our campus. Their interactions have resulted in exchange of rich ideas and learning more about other cultures by all of us.

Recently, eminent educationist, Prof. Ali S. Asani, Chair of the Department of Near East Languages & Civilization, Harvard University was invited in R.S. Campus on 21st November 2013. He was also accompanied by Dr. Kashyap Choksi, Senior Director of International Advancement, Harvard University.

Prof. Asani was received by Shri Ashok M. Saraf, President, Rajasthani Sammelan and other members of managing committee and trustees at Devendra Lath Communication Centre. Initially, he was shown a brief presentation about the institutions of Rajasthani Sammelan. At Devendra Lath Communication Centre, Prof. Ali Asani interacted with management members. It was a pleasant surprise to know that Prof. Asani also teaches Sanskrit language to students at Harvard University. Thereafter, he was taken for a tour of all institutions.

At Nathmal Garodia Seminar Hall of Durgadevi Saraf Institute of Management Studies, Prof. Ali Asani spoke on "The need Shri Madhusudan Maheshwari, Trustee, Rajasthani Sammelan presenting a floral bouquet to Prof. Ali S. Asani

of enhancing Religious Literacy and Cultural Competency in a Globalized World". In this seminar, he emphasized on how religious literacy is essential in our times. Since 9/11, Prof. Asani has been educating people about Islam and believes that most people all over the world are ignorant and misinformed about Islam. Our educational systems have failed to provide a corrective way to prevent political and social unrest rampant all over the world which is mainly due to religious illiteracy.

During the course of his talk, Prof. Asani stressed upon the fact that studying religion is an integral part of human experience. He said that all societies are made of different people. They belong to different religious

groups, ethnic groups and speak different languages. Often they hate people following other religion, speaking other language and having separate cultural traits. This global illiteracy about religion and culture of different groups results in differences all over the world. This leads to more and more polarization.

Prof. Asani stressed on the fact that we do not provide in our education system the scope to understand about religious literacy. He quoted the views of Muhammad Ali Jinnah and Vinayak Damodar Savarkar expressing the difference between Hindus and Muslims. However, he further quoted Mahatma Gandhi who said that "My whole soul rebels





against the idea that Hinduism and Islam represent two antagonistic cultures and doctrines. To assent to such a doctrine is, for me, a denial of God".

Prof. Asani further quoted Maulana Abdul Kalaam Azad who said that 'I am proud of being an Indian. I am part of the indivisible unit that is Indian Nationality. I am indispensable to this noble edifice". Prof. Asani further quoted from Rigveda stating "Ishtadevata" principle "Truth is one. The wise speak of it in many ways. One truth,

unchanging and monolithic.

- Religions seen as actors having agency.
- 5) The use of religion as the exclusive lens to explain the actions of an individual or a community.
- 6) An entire religious community is held responsible for the actions of an individual.

Prof. Asani gave the example of cultural and religious harmony of Indian Muslim Prince

Prof. Asani finally concluded by enumerating dangers of religious literacy for democracy. He said that democracy cannot function if one is ignorant and afraid of one's neighbour. Religious illiteracy diminishes respect for diversity. Further it strips people of their humanity and such a situation can be exploited by extremists or fundamentalists.

At the interactive session, many questions were asked to Prof. Asani. It was asked that



Quran, "Wherever you turn is the face of God and about unity of existence as every nation and people have been sent a messenger from God".

Prof. Asani said that differences between nations and people due to religious differences are manifested through following religious illiteracy:

- Equation of religion with devotional practice, rites, rituals and ceremonies.
- The essence of religion is perceived as located in sacred texts.
- Religious traditions seen as timeless and

translated Hindu religious texts, the Upanishads from Sanskrit to Persian.

Prof. Asani said that real 'Clash of Civilizations" is not between "Islam" and the "West" but instead within virtually all modern nations. They need to respect each other who are different from them. Then only people can live in harmony. Prof. Asani felt that to understand each other's religion we have to approach through cultural studies that considers religion as a phenomenon that is deeply imbedded in all dimensions and contexts of human experience. It is intricately woven within complex historical, political, economic, social, literary and artistic contexts.

many paths". Prof. Asani also quoted from & Mystic Dara Shikoh (1659 A.D.) who How do we teach religious literacy to students as our prescribed syllabi does not have such subjects. Prof. Asani replied that we can do that through our day to day teaching and in a simple way by spreading the message to the children that all of us are equal and we need to be tolerant to difference in culture and religion of others. This interactive session was attended by over 150 Heads of Institutions, Teachers, Students and eminent personalities from across the city. While leaving Prof. Asani congratulated the Management members for their excellent educational endeavours.

About PROF. ALI S. ASANI

orn in Nairobi, Kenya, Prof.
Ali S. Asani is the chair of the
Near Eastern Languages and
Civilizations Department and the Director of
Prince Alwaleed bin Talal Islamic Studies
Program at Harvard University. He is a noted
scholar of Islam and South Asia.

After completing his high school education in Kenya, he attended Harvard College, with a concentration in the Comparative Study of Religion, graduating in 1977. He continued his graduate work at Harvard in the Department of Near Eastern Languages and Civilizations, receiving his PhD with high distinction in 1984. Since then he has been on the faculty at Harvard providing instruction in Islamic mysticism and Islamic civilisations with a particular focus on India, Pakistan and Bangladesh. He also offers instruction in various South Asian and African languages. He has taught at Harvard since 1983, offering instruction in a variety of languages such as Hindustani, Sindhi, Gujarati, Kachchi and Swahili as well as courses on various aspects of the Islamic tradition.

The recipient of several awards and grants, Professor Asani is the author of many scholarly journal and encyclopaedia articles, book chapters and several books on the devotional literatures of Muslim communities in South Asia, including the Bujh Niranjan: An Ismaili Mystical Poem (Harvard University Press, 1992), The Harvard Collection of Ismaili Literature in Indic Languages: A Descriptive Catalog and Finding Aid (Macmillan Reference, 1992),



Celebrating Muhammad: Images of the Prophet in Popular Muslim Poetry (University of South Carolina, 1995) and his most recent book, Ecstasy and Enlightenment: The Ismaili Devotional Literatures of South Asia (I. B. Tauris in association with The Institute of Ismaili Studies, 2002). He is also the author of Let's Study Urdu: An Introductory Course (Yale University Press 2007) and Let's Study Urdu: An Introduction to the Script (Yale University Press 2007 - co-author).

Professor Asani also serves on the editorial board of the Journal of the Institute of Muslim Minority Affairs, Muqarnas, Journal of the Visual Arts of the Islamic World and the Khoj Journal of South Asian Studies.







DGMC campus was also visited by ex Director General Doordarshan Shri M.P Lele.



Career assessment test, IQ test, Personal counseling and Remediation sessions for the students have been an ongoing activity at the centre.



Draupadidevi Sanwarmal women's hostel HEAVENLY DOMICILE

Established in 2012

Draupadidevi Sanwarmal Women's Hostel continues to be the safest place for students coming from other cities to stay and pursue higher studies and thereby fulfill their career dreams. The management has provided all facilities for the safety and comfort of the students staying in the hostel.

In the past few months, our management took decision to increase the capacity of the hostel from 102 beds to 133 beds with the facility of air-conditioning of some of the rooms. Accordingly, for the next session beginning June 2014, we will have the following categories of rooms

- 1) Double sharing A.C. rooms @ 17,000/- pm
- 2) Triple sharing A.C. rooms @15,000/-pm
- 3) Triple Non A.C. rooms @11,000/-pm

The room charges include 24 hrs free wifi as well as laundry facilities along with complementary breakfast and dinner for all inmates. The students who had not applied for renewal vacated the hostel by 31st December. However, many new students were accommodated in the vacant seats. New catering services for R.S. Campus as well as the hostel was started by Team India Managers Ltd., from 7th October, 2013. As provided earlier, breakfast remained

complimentary for all inmates from Rajasthani Sammelan and new items were served every day. The management further decided to provide dinner also as complimentary for all the inmates for the new session of January, 2014 to June, 2014.



Green Economy

The global recession has brought new attention to chronic structural flaws in current economic models and assumptions. As economies struggle to recover, many are taking a closer look at the broad concept of a 'Green Economy', one that simultaneously promotes sustainability and economic growth.

A green economy can be thought of as an alternative vision for growth and development, one that can generate growth and improvement in people's lives in ways consistent with sustainable development.

A green economy is based on triple parameters, i.e. sustaining and advancing economic growth, environment protection and social well being.

The prevailing economic growth model is focused on increasing GDP above all other goals. While this system has improved incomes and reduced poverty for hundreds of millions, it comes with significant and potentially irreversible social, environmental and economic costs. Poverty persists for as many as two and a half billion people and natural wealth of the planet is rapidly depleting. In a recent global assessment, approximately 60 percent of the worlds natural resources were found to be degraded or used unsustainably. The gap between the rich and poor is also increasing between 1990 and 2005. Income inequality rose in more than two thirds of countries.

The persistence and degradation of the environment can be traced to a series of market and institutional failures that make

the prevailing economic model far less effective than it otherwise would be in advancing sustainable development goals. These market and institutional failures are well known to economists, but little progress has been made to address them. E.g. there are not sufficient mechanisms to ensure that polluters pay the full cost of their pollution. There are 'missing markets', meaning that markets do not systematically account for the inherent value of services provided by nature, like water filtration or coastal protection. A 'market economy' alone cannot provide public goods, like efficient electricity grids, sanitation or public transportation. An economic policy is often shaped by those who wield power, with strong vested interests, and rarely captures the needs and requirements of those most at risk.

A green economy attempts to remedy these problems through a variety of institutional reforms and regulatory, tax and expenditure based economic policies and tools.

Key Elements of Green Economy

- The concept green economy focuses on end use i.e. satisfaction of needs and requirements of every individual and the total environment. Any material is a means to satisfy the real need and has to be properly conserved for the future generations. Money also has to be circulated in the economy to facilitate regenerative exchanges.
- 2. The economy takes into consideration the resources like solar energy, renewable

- energy, natural hydrological cycles, regional vegetation, food webs and local materials.
- In nature there is no waste, as output of every process is an input for some other process. It implies interdependence of various systems in the life.
- Green economics is with peripheral vision. It has inherent problem solving strategies that automatically develop positive side effects from any one set of actions.
- Green Economy believes that every regenerative activity has its most appropriate scale of operation.
- The world is characterized by diversity of various nature. i.e. diversity of species of eco systems and of regions.
- Different economic systems should not be self sufficient but should be flexible and dependent on each other.
- 8. The most affected sections of the society should be involved in decision making process New information and communication technologies can facilitate the process.
- All round human development including development of social, aesthetic and spiritual capacities is required for creative mind. The qualities of giving and real service are required to be inculcated in the society.
- The greatest efficiency gains can often be achieved by simple components and their conservation.
- 11. Efficiency improvements can have





impact on the entire economy. So, for achieving the benefits of given economy each sector has to be visualized with proper perspective. This vision coupled with practical action in each of the sectors, can take the economy gradually towards Green Economy.

The term 'Green Economy'- extention of the terms Sustainable growth

In many ways, green economy objectives are in line with the broader goal of sustainable development. But this new concept goes beyond in terms of understanding and realization of real situation.

Firstly, today many governments, companies, society and the public are aware that we are reaching planetary limits, not just in terms of green house gas emissions but also in our use of water, land, forests and other natural resources. The over exploitation of the natural resources is believed to have resulted due to the absence of adequate and meaningful collective action or the persistence of abject poverty.

The environmental and social cost of the current economic model are becoming more and more visible. The management of natural resources through collective action and proper rules and regulations may act as catalyst in finding remedies.

Earlier, sustainable growth efforts were not focused sufficiently on fixing the failures of economic policies. But now we are more aware to tackle these challenging problems by taking appropriate policy measures.

Secondly, and perhaps even more important, the global recession has compelled the policy makers to reconsider the key elements of the current economic model. They are in the process of finding out:

- Policies and regulations that can identify and manage financial and other risks more effectively.
- New markets and industries that can create good, long term jobs
- The ways for strengthening the competitiveness of the society and the country by adopting new technologies and innovations.
- The measures for optimum utilization of country's natural resources.
- The means to percolate the benefits of economic growth to the lowest strata of the society.
- So, these new generation leaders are in

search of new sources of growth that are environmentally and socially sustainable. For eg, employment in high growth sectors such as clean energy.

Challenges of Green Economy

There is a need for a type of development which would make the society not only materially sufficient but also environmentally sustainable and socially equitable. The principal challenge is to create an economic system that will benefit more people over the long run. There has always been a concern to know whether development is becoming all pervasive transcending beyond the boundary of economic orthodoxy.

A few well pertinent questions are often asked and analysed in various circles including policy makers, researchers and governments. Does economic growth ensure equality? Does economic growth take care of poverty? Does social sector get enough attention? Are cultural perspectives addressed adequately? Does development ensure a sustainable environment?

While these have been serious concerns and efforts to ameliorate inadequacies in social sector development, there are other vital issues that have created worldwide debates and discussions including India. Amongst them, the most pertinent issue is the sustainability of our environment. Growth of income is inevitable, but no country can afford to ignore or pay scant attention to the sustainable use of our natural resources. While maximizing current human welfare, it is essential to honour natural resources constraint for the sustainability of the humanity. In underdeveloped economies, major portion of the population lives in rural areas and are solely dependent upon agriculture, fishing, forestry and like Such population are greatly affected by increasing degradation of the nature resource base. The over exploitation of the natural resources is believed to have resulted due to the absence of adequate and meaningful collective action or the persistence of abject poverty. It can also be due to the growth of income and concomitant consumption requirements, which one wasteful and unnecessary.

Other important facets of development interalia are the dynamics of labour market, gender issues, caste representations and cultural perspectives that may require special attention as they determine the social harmony cohesion and sustainable social environment. It is imperative to know the attributes of the labour market with

regard to its composition, level of protection, the magnitude and types of migration and the like.

Thus, in order to achieve sustainability, development has to be pervasive covering the critical aspects such as education, health, gender equality, regional disparity, child labour, environmental sustainability, cultural perspectives etc.

Transitioning to a green economy will require a fundamental shift in thinking about growth and development, production of goods and services and consumer habits. This transition will not happen solely because of better information on impacts, risks or good economic analysis, Ultimately, it is about politics and changing the political economy of how big decisions are made.

The following steps would help create more level policy making playing field:

- Increase public awareness and the case for change-Greater visibility on the need for this transition can motivate voters and citizens not just because of the costs but also the economic benefits generated by a green economy, such as new jobs and new markets.
- Promote new indicators that complement GDP- Planning agencies and finance ministries should adopt a more diverse and representative set of economic indicators that focus not only on economic growth but also on sustainable development.
- Open up government decision making processes to the public and civil society-This would help to ensure that the policies are accountable to the public and not to vested and well connected interests.
- Identify and take advantage of political leadership, when available, as this will be crucial in order to limit the undue influence of 'dirty' economic hold outs.

Ultimately, the widespread transition to a green economy will depend on whether or not the long term public interest is reflected in today's economic policies.






