





of our country. At the same time, there is also the need to train and develop the teaching staff and give them opportunity to engage themselves in research activities.

It is a known fact that funding of the educational institutions by the state or central governments is slowly dwindling and therefore a public – private partnership model is needed to be developed and encouraged by the government to create a self-sustainable model of education in times to come.

In Maharashtra, the first private / self-financed universities are likely to be a reality from the academic year 2014-2015, as the state government has issued a government resolution (GR) in this regard. So far, companies like Reliance & Bharat Forge have shown interests. Besides, D.Y. Patil Group engaged in educational activities in Mumbai and Ajinkya University, Pune, have also held preliminary discussions with the state government on their proposed venture.

Once the proposal materializes and industry is linked with education, there will be involvement of the industry in curriculum development and also in the implementation of the curriculum. Industry will be able to utilize the human resource available in the universities for problem solving, testing and certification. To achieve excellence, it is necessary to create a partnership between government, educators and industry. Such partnership can provide our high tech industries with skilled workers who meet the standards of their industry.

The twelfth five year plan projects that enrollments in all degree and diploma courses at higher educational level has to increase from the current 20 to 30 million in India with particularly high rates of growth in Ph.D, post graduate and under graduate technical education. Entry of self-financed private

universities will definitely be able to absorb this proposed projected growth of enrollment of students in higher education.

Close to the heels of the

private self-financed universities is the growing popularity of Indian Institute of Information cess in IT industry, the development other electronic technologies, our

Technology. India's recent success in IT industry, the development of indigenous satellite and other electronic technologies, our ability to creatively use the internet and the increasing success of Indian entertainment, export, film, T.V. and music draw attention to India's competitive advantage in these fields. The IT industry has thus already captured the imagination of world. Technical professionals produced in IIITs will further consolidate the position of the Indian software and information technology industry in the global market.

Due to this, Indian Institute of Information Technology is becoming popular all over the country. IIITs are at present a group of four institutes of higher education in India at Allahabad, Gwalior, Jabalpur and Kancheepuram focused on information technology. Maharashtra Government has also decided to set up the Indian Institute of Information Technology in Chincholi, near Nagpur.

At school and higher secondary levels, many parents prefer to admit their wards in the schools affiliated to ICSE and CBSE Boards compared to the State Board. At the same time, there has also been preference of the parents for private unaided schools for their infrastructural and other facilities offered to the students.

At Rajasthani Sammelan, we have all types of school - from aided to unaided, from State Board to International Boards of IB and IGCSE, to offer to the students. We are hopeful that in near future, Rajasthani Sammelan will also take up such mega projects of establishing a self-financed university or an Indian Institute of Information Technology to carry its educational endeavours forward to a greater height and also for the benefit of a larger section of the student community.






As we go down the memory lane, on 21st June, 1959, the first institution, Sarvodaya education Balika Vidyalaya (now known as Kudilal Govindram Seksaria Sarvodaya School) was inaugurated by Dr. Kalulal Shrimali, the Union Education Minister. 
Helen O'grady International, our partner institute has continued with their classes of Teacher Training during this phase.





However, the most noteworthy facility introduced in this period was starting of a Cafetaria in R.S. Campus which helped in timely serving of breakfast, lunch and dinner to the inmates of the hostel. We continued our tie-up with local physicians and nursing homes to provide timely medical help to the students who needed it.

The management also took full care for the maintenance of the infrastructure. One of the major steps taken by the management is the proposal of making few rooms air-conditioned as per the request of some students and their parents.

In the area of administration, Online data base of students was prepared for the ready reference of the management and hostel staff by the IT Department of Rajasthani Sammelan. At the management level, regular meetings of the Hostel Committee were held to discuss the issues concerning the hostel and to provide maximum comfort to students, so that they can pursue their studies in a congenial and peaceful atmosphere.

MANAGEMENT EDUCATION IN INDIA







Dr Sharad Kumar Remsons Chair Professor, Durgadevi Saraf Institute of Management Studies (DSIMS).

Significance of Management Education

Liberalization, privatization and globalization and through economic reform measures adopted by India in early 1990s, have made a sea change

in the way the business and commercial activities are conducted in India. The globalized economic environment has forced the business entities to improve their efficiency and adopt world's best practices to survive and grow in a highly competitive market economy. During the same time, the advances in information and communication technology (ICT) has facilitated the business activities to enhance their operational efficiency and meeting the expectations of highly demanding customers. The business activities therefore have become extremely complex requiring continuous improvement of systems and processes, innovating new products & services and making strategic decisions. This has thrown a great challenge to managers for conducting business effectively. These challenges have surged the demand for business education for developing effective managerial skills and orientation.

Till late 1980s, the number of business schools in India could be counted on finger tips. The 3 first generation IIMs (IIMA, IIMB and IIMC), XLRI, JBIMS, FMS and the Management Departments of few established universities were the only Management education providers in the country. These B-schools were meeting the standard demand for management education, largely based on western models. In 1990s and 2000s, the favourable global business environment

provided great opportunities for business education, particularly in high growth developing economies requiring customized business education aligning with the needs of their business and corporates.

Increased opportunities for management education have also thrown several challenges for the management education administrators viz. shortage of competent and qualified faculty, coordination and interaction with industry, internationalization of management education to meet global challenges, exposure to rural markets and economy where tremendous business potential exists, diversifying management education to meet the requirements of different segments, branding the institution, etc.

Qualified Faculty - A Crucial Differentiator

The anticipated growth for business education needs has led to the mushrooming growth of B-schools in different parts of the country without adequate infrastructure and expertise. Success of a B-school largely depends upon the quality of its faculty. The shortage of qualified and competent faculty has been witnessed even in the best of the B-schools like IIMs, where they are operating with less than 50% strength resulting into an adverse teacher student ratio. Thus, acquiring good faculty is a major challenge for both new as well as established B-schools. Though the demand for business education is growing at a larger pace during last two decades, the production of qualified faculty especially with Ph.D. degrees has not been adequate to meet the demand. This shortage will continue for times to come and there is no quick fix solution to this issue. UGC and AICTE rules provide the glass ceiling for non-Ph.D. academicians for their career growth. Inspite of improvements in the salary structure of teaching staff by the successive pay commissions, the B-

schools are not able to attract the best talents. In most of the top ranked B-schools, the average salary offered to a fresher is higher than the average salary of their faculty with 20 years of average experience. Few reputed faculty are, however, able to enhance their earning through consultancy assignments.

The involvement of practicing managers as visiting faculty becomes fruitful to bring practical aspects of management learning in classroom; an appropriate mix of academicians and practitioners can compensate the shortage of faculty to some extent. This is however, not possible for the business schools located in small towns where the presence of corporates is negligible.

The information and communication technology has aided in revolutionizing the teaching and learning methodology by enhancing the reach to multi-locations and larger audiences in real time. The technology could create an interactive learning environment of a virtual class room. It can also help the learner to learn at his/her own convenience and pace through interactive videos. However, the new form of technologically supported teaching and learning tools cannot undermine the need for competent faculty and classroom model.

Institute-Industry Interaction

Success of a B-school depends upon how well it anticipates the emerging manpower requirements of industry and how well it trains and develops its students to make them job ready. It requires a close coordination and interaction between B-schools and industry. There are many issues to be addressed in this regard. Firstly, the curriculum is required to be evolving around the emerging needs of the industry. This is possible if the B-schools have the freedom to modify their curriculum on regular basis. The B-schools are generally able to adopt





the curriculum for their diploma courses like PGDM, but this flexibility is not available for university affiliated courses (like MMS of Mumbai University). The curriculum laid down by the respective universities is not revised periodically, resulting into its fast obsolescence. Secondly, unlike western world, most of the students of business education are fresher and lack practical orientation to link classroom learning to work place applications. The case study methodology tries to bridge this gap to some extent. The summer internship also tries to address this issue but the organizations where these students are placed are not able to provide adequate orientation due to their own pressing demands. Sometimes, the summer interns are utilized for routine jobs which hardly provide any learning regarding practical applicability of management tools and techniques. Thirdly, there is lack of adequate interaction between academicians and management practitioners for jointly finding the solutions of problems faced by the industry in the form of research and consultancy. Only a few top B-schools are able to venture these initiatives.

Need for Internationalization of Business Education

The emerging integrated and interdependent global business environment demands adequate international exposure and global orientation of the management students to understand the business context and business demands. Many B-schools provide some opportunity to its students for international exposure through (i) international immersion, under which the students are sent to few countries to visit some business units, multinational organizations and educational institutions to get a feel of international business environment and processes; (ii) exchange programmes with some international institute whereby students from one country complete part of their curriculum in the partner institute of other country; and (iii) setting up multiple campuses located in different regions of the world. These interconnected campuses share their regional expertize and exchange the students for wider exposure.

Need for Rural Exposure

More than 2/3rd of population lives in rural India. The corporates are recognizing the tremendous, untapped business opportunities in rural India and focussing their business strategies in that direction. The B-school students are required to be sensitized to the needs of rural population and create

awareness of rural economic activities and market potentials. Some of the proactive B-schools arrange the rural visit of their students to interact with villagers, rural institutions, rural markets, etc. and collect qualitative and quantitative information to analyse the income, expenditure and economic activities of rural folk.

Diversification of Management Education

Most of the B-schools have diversified the management education to cater to the needs of different segments and also to make the business model more financially viable. Bschools are venturing into corporate training by offering tailor-made management development programmes (MDPs). These short duration programmes are generally useful for the managers who cannot be relieved for long duration programmes. Bschools are also offering full-fledged long duration degree/diploma courses for the working executives. These part-time courses help them to meet their career growth aspirations. For example, the MFM, MMM and MHRDM are the three year parttime degree courses offered by many institutes in Mumbai conferring degree of Mumbai University. The institutes also offer few long duration diploma courses to cater to the needs of entrepreneurs running their family business and programme for women entrepreneurs planning to start their own business, etc. Such programmes are generally offered during weekends so that they don't clash with the business activities of these entrepreneurs. The main objective of such programmes is to equip the entrepreneurs to conduct their business professionally and organized manner by interlinking various management functions. Some of the institutes have also diversified into highly specialized diploma courses like Risk Management, Retail Management, Supply Chain Management, Health/Hospital Management, etc.

B-Schools Branding

The MBA aspirants and the recruiters are always interested in the reputation and ranking of B-schools. The student always like to choose a branded school in order to get a better job and package, whereas the recruiter is interested to get an employee who has been educated and trained by a reputed institute. Many agencies bring out the ranking of various B-schools in India adopting different methodology. Except for few top ranked B-schools, the ranks of various schools widely vary creating a doubt about the methodology and the intentions of

these rating agencies. Generally, the factors like reputation, infrastructure, placements, faculty, average package, teaching methodology, admission eligibility are the key factors for the B-school branding. BT-Nielsen, who has been carrying out such ranking for last 11 years believes that "an institute is as good as its customer thinks it to be". Thus, the perception of MBA Aspirants, Recruiters and Currents Students is crucial for the reputation of any B-school. The accreditation and ISO certification helps in branding of an institute.

Conclusions

The demand for business education has increased many folds during the last two decades but the number of B-schools has outgrown the demand which has posed many challenges. Finding competent faculty; creating bonding with industry and aligning curriculum to their needs; adopting learner centric pedagogy; internationalizing business education; providing adequate industrial and rural exposure to students and branding the B-schools, are the major challenges faced by a large number of Bschools. With the mushrooming growth of B-schools without adequate expertise the quality of management education is suffering and at the same time many of the ill-conceived B-schools are not finding adequate number of students to sustain their existence.

It has a seating capacity of approximately 300 persons & is mainly used for organizing seminars, conferences & cultural activities of the educational institutions of the trust. Besides, it is sometimes also given to the members of the community for marriage & other social needs. The hall has all the facilities to cater to business meetings. It has 2 air conditioned rooms adjacent to the hall.



Established in 2010

To maintain universally accepted IT Standards in security, availability and data management, Rajasthani Sammelan has decided to have an IT Hub as proper data centre which is supported and managed 24 x 7. The IT Hub is constructed on the 10th floor of the new building, in a built-up area of 3800 sq.ft. It is fully air conditioned and is operational. The main aim of constructing the IT Hub is to make all course material available on line to our students, easy flow of interaction between student and teacher through electronic medium, to create alumni data and keep students attached to our organization life-long through web, to safe guard the campus using video vigilance and electronic access control, to control the entire admission process of all institutions centrally, to safe guard all available data and provide fast internet services within the campus.



New Initiative

Rajasthani Sammelan proposes to start an educational outlet in its campus by the name of Ramnarayan Saraf Educational Outlet. This educational outlet is dedicated to the memory of late Shri Ramnarayanji Saraf.lt will be constructed in the basement of the new building of Ramniwas Bajaj English High School on the rear side in a built-up area of 5000 sq.ft. On the ground floor, there will be an independent entrance from the Sports Complex. In this educational outlet, all stationery items, rain coats, text books etc. will be sold at a reasonable price so that students need not go out to purchase such items else where.

The cafeteria supplies all kinds of snacks and beverages to the canteens of all the institutions of Rajasthani Sammelan.

A new Principal, required teaching and non-teaching staff will be appointed as per requirement.



Rajasthani Sammelan has started Remsons Group Management Research Centre (in memory of Radhadevi Harlalka) in Durgadevi Saraf Institute of Management Studies. Research is an important part of management education for its growth and development. Remsons Group Management Research Center has been playing an active role in the area of research in management studies. The Director as well as faculty members of DSIMS have been presenting research papers in many international and national seminars and workshops. 


NOT ENOUGH QUALITY INSTITUTIONS TO EDUCATE NEXT GENERATION: PRESIDENT



Pointing out that there was a dearth of high quality academic institutions in the country, President Pranab Mukherjee on Wednesday regretted that Indian universities were not counted amongst the top-ranked universities in the world. "Unfortunately, it is a sad reflection on us when the universal ranking of universities comes out. There is not even a single Indian university among the top 200," Mukherjee said at the 23rd annual convocation of Pondicherry University.

Stressing on the need to keep pace with change, he said the 12th Five Year Plan would focus on 'expansion, equity, excellence, governance, funding and monitoring'. "These aspects have to be implemented in the right spirit for the higher education sector to see far-reaching changes. The academic curriculum has to be updated regularly. The assessment system has to be made more reliable and objective," he said.


India had dominated higher education for 1,800 years from 6th century BC to the fall of Nalanda University in 12th century AD. "I don't find any reason why India cannot go back to dominating the higher





Advising universities to create an environment supportive of innovation, he said teaching and research were the two eyes of a university. "High standards in teaching should be achieved and high quality research should be promoted to push knowledge frontiers and evolve technologies for development". He said new products that are useful to the common man should be designed. "Our innovations have to create livelihood and improve the quality of life in rural areas," he said, urging universities to address local technological needs by creating research and development centres. Research campuses also have to be set up in rural areas to act as fountainheads for innovation and technology-led growth in these regions.

"As students, you have had the benefit of progressive education system. As you now enter a stage where you can give back to society, make your contributions and make it count," he said. As for faculty members, Mukherjee said they were the lifeblood of a university. "They (the faculty) must be able to transfer knowledge to their students with dedication and commitment. They must act as a friend and guide to the students, ever willing to counsel and show them how best they can gear themselves to face the world." He pointed out that there were 659 higher educational institutions and 33,000 colleges in the country. Presently 1.8 crore students have enrolled for higher education and the students' strength is expected to touch 2.9 crore by the end of 12th five-year plan, he said.



IMPROVING QUALITY OF EDUCATION

The first ever meeting of the governor's committee on improving quality of higher education met in Mumbai on Wednesday.

The eight member committee has been set up by President Pranab Mukherjee. Maharashtra governor K Sankaranarayanan is the head of the committee.

The other governor's who are members of the committee include Dr D Y Patil from Bihar, Nikhil Kumar from Kerala, Bharat Vir Wanchu from Goa, Jagannath Pahadia from Haryana, Lt-governor from Delhi Najib Jang and the governor of Andaman-Nicobar and Puducheri.

Amongst the issues discussed were the appointment of vice-chancellors, the unavailability of trained and experienced teachers, improving students grades, providing student loans and creating an environment for research.

The committee will submit its report to the President, said a press release.

MUMBAI: After the Joint Entrance Exam (JEE) results, coaching classes get busy spinning success stories. Each student who makes it to the hallowed Indian Institutes of Technology (IITs) may just be reduced to a rank, but it is their golden ticket to netting more candidates for admission. But information collected by the tech colleges reveals that close to half of those who make their mark in the entrance test prepare for the exam on their own.

The IITs ask every student who takes the JEE whether he/she prepared for the test "on his own or via other methods", which, in short, covers all sorts of coaching provided. This includes classroom series, distance learning, referring to tutorial notes or appearing for mock tests. Candidates are also informed that their selection would be based on the marks they have scored, irrespective of their preparation method.

Data provided by candidates shows that about 50% students said they studied on their own. Their share has altered over the years. Data analyzed by the JEE cell reveals that while 60% of the students who made it to the seven old IITs in 2007 opted for some form of coaching, in 2008, this figure dropped to 45%.

Coaching classes, though, insist that their enrolment numbers have been ballooning every year.

Prayeen Tyagi, proprietor of IITians Pace, said the statistics were not authentic. "My students ask me if they should disclose that they took coaching.

We, like most other classes, advise them against doing that. For, we fear some day the IITs may decide to favour those who didn't take coaching."

Heads of coaching centres say it isn't easy to bag a rank without professional help. Vijay Singh, who taught at IIT-Kanpur, recalled that the coaching phenomenon became big only in the mid-90s. "Even in the 80s, a tiny proportion of the class did prepare for JEE through a coaching class. But Kota emerged in the early 90s as a coaching hub, and in one particular year, a large percentage of students who qualified from Bombay zone (with covers Rajasthan too) was from there," he said.

Soon, aspirants swelled, and the premier colleges also multiplied to meet growing demand. Coaching academies mushroomed and fed on the IIT craze that had caught on.

In 2005, the IITs were forced to look inwards, and a committee headed by C N R Rao, principal scientific advisor to the prime minister, limited JEE attempts to two, to tackle the coaching phenomenon. "Students who came in after spending years in coaching classes used to burn out very fast; most took six to seven years to complete the four-year course," observed an IIT-B faculty member.

In fact, the coaching syndrome is so deeply ingrained that IIT insiders too doubt the authenticity of the data they have collected. A faculty member who teaches mathematics in IIT-Guwahati did not agree with claims made by students. "I do not think all students are giving us the correct picture on the coaching front. Surely, there are some students who make it from extremely poor and disadvantaged backgrounds, but I feel most other candidates take some sort of coaching," he said.

MAJOR PUSH TO CHANGE THE FACE OF HIGHER EDUCATION

Times of India, October 5, 2013

The Rashtriya Uchchatar Shiksha Abhiyan (RUSA)—cleared by the Cabinet committee on economic affairs (CCEA) on Thursday—is not only the first major intervention by the Centre to reform the state higher education system but also a substantial step to partially clip the wings of the University Grants Commission (UGC).

Ministry sources said the 2004-05 proposal to amend the UGC Act — complete with renaming the organisation as higher education commission and taking away a major chunk of its grant-giving power — has been revived. After RUSA, UGC would continue to fund around 52 educational institutions, which includes 40 central universities and another 12 deemed universities under the government.

UGC would also continue to look after funding research initiatives and conducting of National Eligibility Tests. Its primary function would be to ensure academic standards and accountability. UGC has already been given the Distance Education Council (DEC) and after the Supreme Court order even the work of the All India Council for Technical Education (AICTE) is likely to be given to them in the near future.

"Several committees over the years have recommended that UGC should focus on maintaining academic standards," a ministry official said. RUSA, which would entail an expenditure of Rs 98,134 crore over 12th and 13th Plan, will be implemented in a mission mode by a Special Purpose Vehicle and a Technical Support Group. Like the successful Sarva Shiksha Abhiyan (SSA), funding for RUSA would be shared between the Centre and the states in the ratio of 65:35.

For northeastern states, J&K and Himachal Pradesh, the Centre and state funding would be in the ratio of 90:10.


