Report to College Development Committee (CDC) and Communication with Board of Studies of affiliated University.

- Faculty members from various departments actively participated in university syllabus revision workshops. (SYBSC-IT syllabus revision workshop and MCom Part I - Accountancy and Management NEP Workshop).
- The workshops aimed to align academic programs with the evolving needs of the job market and incorporate recommendations gathered through feedback.
- Through collaborative efforts and insightful discussions, faculty members worked to integrate industry-relevant knowledge and skills into the curriculum.
