Testing rounds:

The testing process would comprise of 6 rounds of pre-screening tests (Part A to F; 17 Minutes) and 1 business proficiency test (1 Hour 15 Mins). The details of which are shared below. Only the students who clear the communication test will be automatically diverted to the business proficiency tests. Students who qualify in all the testing rounds will be scheduled for interviews.

Test	Pre-Screening Details
Part A: Reading	Description: A set of sentences would be displayed on the screen with a number mentioned against each sentence. The system would randomly ask to read a particular sentence ,read out the same sentence as asked. Number of Questions: 8
Part B: Repeat	Description: Listen to a sentence and repeat the sentence word-for-word. The sentences are presented in approximate order of increasing difficulty. Number of Questions: 16
Part C: Simple Questions	Description: Give simple answers to questions being asked. Number of Questions: 24
Part D: Sentence Build	Description: Listen to a group of three short phrases presented in random order and then rearrange the phrases to make a sentence. Number of Questions: 10
Part E: Story Retelling	Description: Listen to a short story that would be spoken and retell the story in your own words. Number of Questions: 3

Part F:**Open Questions**

Description: Questions will be about life or personal choices, you will have 20 seconds to reply to the question.






