

MEMORANDUM OF UNDERSTANDING

The University of the Fraser Valley (UFV), and Ghanshyamdas Saraf College of Arts & Commerce (GSCC), wish to enter into this Memorandum of Understanding (MOU) to promote international and intercultural understanding and academic cooperation and collaboration.

Purpose

The purpose of this MOU is to provide a framework for the future development of academic and educational cooperation.

- 1. The parties will explore academic and educational activities of mutual interest on the basis of equality and reciprocity.
- 2. Initial areas of collaboration and cooperation may include, but not be limited to, the following:
 - a) Both parties promote to gain a better understanding of the programming at each institution;
 - b) UFV representatives regularly attend recruitment/info sessions at the partner institution;
 - c) UFV will accept students from GSCC who meet entrance criteria that have been agreed upon by the parties in prior consultation;
 - d) Both parties discuss ways to deepen the relationship going forward, which could, for example, be in the form of targeted scholarships.
 - e) The initiation of a "2+2" transfer agreement (articulation) leading to degree completion at UFV in Computer Information Systems (BCIS)
- 3. The details of any specific activities based on this MOU will be separately negotiated between the parties and set out in a separate agreement.
 - For Item 3, Both UFV and GSCC recognize STAAR UNIADVISE PRIVATE LIMITED (UFV agent ID: IN427) to be representing GSCC.
- The parties understand that the implementation of any activities stated in Clause 1 or 2 above shall depend upon the availability of resources and the financial support of each party.
- 5. This MOU is a statement of understanding and is not intended to create a legally binding contract.
- 6. This MOU may be amended or modified by a written agreement signed by both parties hereto.
- 7. This MOU will be effective from the date of the last signature below and shall remain in effect for a period of five (5) years from the date of signing, unless earlier terminated as outlined below. This MOU may be renewed, in writing, upon the mutual agreement of the parties.

- 8. Either party reserves the right to terminate this MOU upon six months' written notice to the other party.
- 9. This MOU shall be executed in English. In the event a translated copy of this MOU exists, the parties agree that the English version shall prevail for the purposes of Interpretation.
- 10. This MOU shall be signed in duplicate originals and each party shall retain one original.
