This has reference to your letter No. BGK/2002 dated 30th August, 2002 requesting permission to start the M.Com. degree course in the subject of Accountancy, Business Management and Banking & Finance from the academic year 2003-2004.

In this connection, I am directed to inform you that the Vice-Chancellor considered your request and in exercise of the powers conferred upon him under section 14 (7) of the Maharashtra Universities Act 1994, your college has been permitted to start M.Com. degree course in the subject of Accountancy, Business Management and Banking & Finance and enroll the students for the course to intake capacity of 60 from the academic year 2003-2004 pending the report of the committee appointed under the convener'ship of Dr. Vivek Deolankar to make the local inquiry in respect of infrastructure and facilities available in the college subject to the following conditions:-

- 1) M.Com. Day/Evening classes may be permitted as per the University system.
- 2) Admission to M.Com. Part-I class in the college will be the responsibility of the Principal of the college.
- 3) The time-table and the assignment of teachers to the subject will be the responsibility of the Principal of the college.
- 4) The college will have to appoint a co-ordinator to look after the administration of the Post-graduate center and for liaison with the University.
- 5) The co-ordinator will be paid an honorarium as per the University rules. The duties of the co-ordinator are mentioned in the University letter No. 4203 of 1993. The important duties of the co-ordinator are:-

To supervise the Post-graduate teaching at the center and report to the Principal of the college.

To maintain attendance roll of the students

To obtain from teachers participating in the teaching programme a copy of their attendance sheet along with the incidental expenses bill and submit the same to the Principal of the college for the settlement of payment.

Supervise the library facility and availability of books to the Students.

To arrange for the remittance of University share of Post-Graduate tuition fees.

The Principal and recognized teachers of the college would carry out their responsibilities assigned to them as per the circular number PG 4060 of 1993.

9. The college will develop library for Post-graduate studies in the concerned subjects.
10. The college should ensure that the Post-graduate students get opportunities to utilize the library facility.
11. For Post-graduate commerce section required textbooks and reference books are already purchased by the college. Journals and periodicals required for the post-graduate commerce section are also purchased by the college. In addition to this college will purchase books and journals if necessary.
