2. Encourage the regular faculty members and visiting faculty members of either institute to visit the other Institute for giving talks/delivering lectures in academic programmes, Workshops, Seminars and Conferences in e-Commerce.
3. Encourage students of either Institute to attend lectures in the other Institute during lecture sessions, seminars and conferences.
4. Share the library facilities mutually by giving access of library of either Institute to students, faculty members and visitors of the other Institute.
5. Share facilities of either Institute to students and teachers of other Institute for academic work.
6. Share as per mutual convenience facilities like guest house for visitors and hostels for students.
7. Share video conferencing facilities as per mutual convenience for educational purposes.
8. Encourage the research / students of either Institute to visit the other Institute for short durations for getting research inputs and guidance upon recommendation from the research guides/ faculty members.
9. Encourage guidance for students of either Institute in academic projects by staff members of the other Institute.
10. Encourage joint research activities and projects by the faculty members of LRMNC and ESK.
11. For LRMNC student visiting ESK, student has to bear his own expenses if any. Hostel facility will be provided depending on the availability. No financial obligations will be there on ESK.
12. For ESK student visiting LRMNC, student has to bear his own expenses if any. Hostel facility will be provided depending on the availability. No financial obligations will be there on LRMNC and ESK.

There will be a coordinating committee consisting of the ESK and LRMNC and two additional members from each Institute who will be responsible for the effective implementation of the MoU.

The courses offered by each institute will be recognized by the other institute towards credit requirements for various programmes.

Cost and their considerations

No financial commitment from any party will be assumed unless a formal approval/acceptance to that effect for the works services has been accorded through signed documents by both the parties.


Terms

This MoU shall be effective from February 24, 2022 ("Effective Date") and shall continue to be in effect for a period of 3 years. However, upon expiry of the Term, the Parties may renew this Agreement for further period on mutually agreed terms and conditions.

Termination: The MoU may be terminated at any time by either party upon 30 days written notice to other party. Nothing in this MoU shall give either party any rights to use other party's logo, trade name without prior authority of the party.

Confidentiality and Non-disclosure

- Any Software / hardware material, product specifications, designs, financial, technical information, documents etc. shall be deemed to be in private domain and it shall not be made public or shared with other party without the prior written consent of the party which owns it.
- The material shall be treated as confidential for a period of 3 years after this MoU comes to an end as agreed from time to time in writing.
- In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other appropriate relief. Parties shall sign separate Non-Disclosure Agreement before the disclosure of confidential information

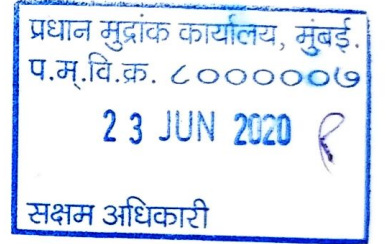
