Affiliated with the University of Mumbai, the college offers undergraduate and postgraduate programs in commerce and related disciplines, emphasizing academic excellence, holistic development, and career readiness located at S.V. consent to engage in a formal exchange agreement grounded in reciprocal trust, with the aim of advancing the development and progress of both institutions while fostering global understanding and goodwill. In consideration of their respective academic and

educational needs, the two institutions shall collaborate in the development of some or all of the subsequent activities:

ARTICLE 1: OBJECTIVES

This cooperation shall include but not be limited to:

1. Facilitate participation in scholarly projects, such as curriculum development for courses, training programs, conferences, symposium, seminars, and guest lectures, with the aim of promoting for the rule of law, religious freedom, and human rights.
2. Publish scholarly books, journals, book translations, and other types of publications with the intention of reaching a broader audience in both nations.
3. Constructing a collaborative network comprising two institutions and external organizations.
4. The reciprocal transfer of faculty and students, as well as visiting fellows, as agreed upon by both institutions as suitable.
5. Cooperation exchange agreed upon by both institutions as suitable.
6. Development and execution of training program for Islamic scholars in Indonesia utilizing Sharia and Human Rights Coursebook as curriculum.

ARTICLE 2: GENERAL PROVISIONS

- A. The Parties shall negotiate and reach an agreement on the development and implementation of particular activities in accordance with this Agreement. Such activities shall be governed by a separate document or memorandum of agreement.
- B. Each Party consents to carrying out these activities in accordance with the laws and regulations of their respective countries, subsequent to comprehensive consultation and approval.
- C. The implementation of any of types of cooperation stated under article 2.A above shall depend upon the availability of resources and financial support of the Parties concerned.

ARTICLE 3: TIME PERIOD

This Agreement will be effective from the date of signature for an initial period of four years. Thereafter it shall be automatically extended for an additional period of four

years at each expiration date unless either party provides written notice to terminate the Agreement a minimum of six months prior to the expiration date.

ARTICLE 4: INTELLECTUAL PROPERTY

- A. The Parties agree to abide by intellectual property rights of each Party created before the conclusion of the present Agreement.
- B. The intellectual property rights created under the present Agreement will belong to the Party creating the intellectual property.
- C. Should the collaborative research activities under this Agreement result in any potential for intellectual property rights, each Party shall seek an equitable and fair agreement as to ownership and other property interests that may arise.

ARTICLE 5: AMENDMENT

Any modifications to this Agreement that are not documented in writing will be deemed void. The amendment or modification to this Agreement shall be signed by the representative of each Party and shall constitute an integral part of the Agreement.

ARTICLE 6: FINAL PROVISIONS

- A. Both Parties shall not use names and logos of the other Party without its prior consent, if it is not directly related to the performance of obligations under this Agreement except as provided by law.
- B. The Parties agree to post on their websites reciprocally information about the partner university, including reference link to the universities' websites and links to online courses.


