NSS was introduced in 1969 with the participation of about 40,000 volunteers from 37 universities. Over the years, it has expanded significantly and now operates in 657 universities and 51 +2 councils or directorates, encompassing 20,669 colleges and technical institutions and 11,988 senior secondary schools. Since its inception, more than 7.4 crore students have benefited from the programme.

3. HOSTEL DETAILS

> Boys Hostel

Jankidevi Bilasrai Bubna Boys' Hostel is located at a walking distance from RSET Campus (**Rajasthani Sammelan Education Trust Campus**, which includes Ghanshyam Das Saraf College, Durgadevi Saraf Institute of Management Studies, Deviprasad Goenka Management College of Media Studies, and **Ladhidevi Ramdhar Maheshwari Night College of Commerce**).

The independent hostel building has seven floors and provides accommodation for 152 students. At present there are 140 students in the hostel. All rooms are air-conditioned and aesthetically designed. There are air-conditioned study areas on all floors where the students can sit and study. Also, all the floors have a lounge and TV room for recreation of the students. Other facilities include a communication room, dining room, and gym facilities. Some gym equipment such as a treadmill, cycle, bench, dumbbells, and other equipment have been provided in the gym of the hostel so that students can work out as per their convenience.

From the past few months, renovation of some areas has been undertaken by the Management. All rooms have been painted before the onset of the rainy season, ensuring a fresh and clean environment for the residents. All air conditioners have undergone deep servicing, and necessary spares have been replaced to ensure optimal performance. Additionally, gypsum board fixing has been done in all rooms to prevent damages or seepage of false ceilings. An AMC has been signed with a reputable vendor for lift maintenance, which includes regular servicing and oiling to ensure smooth operation. In rooms, new pillows and bed covers have been provided to the residents, replacing the ones used earlier. For the safety of the students, the building is equipped with a fire detection and fire fighting system. Recently fire extinguishers have been upgraded, and regular checks are being conducted to ensure compliance with safety norms. CCTVs have been installed for 24 x 7 security of the inmates of the hostel. Cameras have also been installed at the backside of the emergency exit on all floors to enhance resident safety. The building is maintained by a professional house-keeping agency. Recently, new pest control, housekeeping, and security agencies have been appointed to provide better services to the Hostel.

➢ Girls' hostel

Rajasthani Sammelan Education Trust has a spacious educational campus in Malad (West). This educational campus is equipped with Girls' hostel facilities for students. Accommodation is available for 135 students. The hostel building has world-class infrastructure, spacious and adjacent to the colleges (Ghanshyam Das Saraf College, Durgadevi Saraf Institute of Management Studies, Deviprasad Goenka Management College of Media Studies, and Ladhidevi Ramdhar Maheshwari Night College of Commerce).

The rooms are properly ventilated and provided with AC, fans, tube lights, and furnished with beds, cupboards, a chair, and a study table, and each room is attached with a toilet/washroom. Aqua guard is fitted for providing safe and pure drinking water. The hostel has a spacious dining hall with two common refrigerators, microwave, and induction. The seating capacity of the dining hall is 40 students. All 135 students take their meals in the dining hall. We serve breakfast and dinner.

The hostel has a recreation hall with LCD, sofas, and chairs set. There is a solar system of 2000 ltr. capacity fitted in the hostel. The solar system also has electrical backup to heat the water during the rainy season. We have two lifts—one main lift and another for an emergency lift. Also, the hostel is well secured and guarded for 24 hrs. The hostel provides a serene atmosphere and clean surroundings to the students for their study and stay. To inculcate the reading habit of the students, a separate space is given and many more value-based newspapers and magazines have been subscribed.

The hostel campus is well-equipped with a Wi-Fi connection. Some gym equipment for fitness was bought and a separate space has been allotted to do physical exercises. The hostel is equipped with a separate laundry room with 4 washing machines installed and an area for drying within. There are a total of 45 rooms for the students in the DSWH and one Rector's residence flat and 1 room for the Asst. Warden. All the rooms are self-contained.

5. DETAILS OF STUDENT GRIEVANCE REDRESSAL COMMITTEE (SGRC) AND OMBUDSPERSON

COLLEGE GRIEVANCE REDRESSAL POLICY

GRIEVANCE REDRESSAL CELL

Students Grievance Redressal Committee SGRC as per UGC Regulation, 2023 Objective: To provide opportunities for redressal of certain grievances of students already enrolled in the University, as well as those seeking admission to the University, and a mechanism thereto.

Definitions:

- (a) "Aggrieved student" means a student, who has any complaint in the matters relating to or connected with the defined grievances.
- (b) "college" means any institution, so defined in clause (b) of sub-section (1) of section 12A of the Act.
- (c) "Commission" means the University Grants Commission established under section 4 of the UGC Act, 1956.
- (d) "Declared admission policy" means such policy, including the process there under, for admission to a course or program of study as may be offered by the University by publication in the prospectus of the University.
- (e) "grievance" means, and includes, complaint(s) made by an aggrieved student in respect of defined things/cases as per clause 3 (1) (f) of UGC (Redressal of Grievances of students) Regulations, 2023.
- (f) "Ombudsperson" means the Ombudsperson appointed by the University.
- (g) "Prospectus" means and includes any publication, whether in print or otherwise, issued for providing fair and transparent information, relating to a University, to the general public (including to those seeking admission in such University) by such University or any authority or person authorized by such University to do so;
- (h) "Student" means a person enrolled, or seeking admission to be enrolled, in the University, to which these regulations apply.
- (i) "Students' Grievance Redressal Committee (SGRC)" means a committee constituted under the regulations of UGC, at the University level. Composition and Modus-Operandi
- A complaint from an aggrieved student relating to the University shall be addressed to the Chairperson, Students' Grievance Redressal Committee (SGRC).
- The composition of Grievance Redressal Committees (SGRC), will be as follows:
- a) A Professor-Chairperson
- 2. b) Four Professors / Senior Faculty Members of the Institution as Members.
- 3. c) A representative from among students to be nominated on academic merit/excellence in sports/performance in co-curricular activities-Special Invitee.
- At least one member or the Chairperson shall be a woman and at least one member or the Chairperson shall be from SC/ST/OBC category.
- The term of the chairperson and members shall be for a period of two years.
- The term of the special invitee shall be one year.
- The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.
- In considering the grievances before it, the SGRC shall follow principles of natural justice.
- The SGRC shall send its report with recommendations, if any, to the competent authority of them institution concerned and a copy thereof to the aggrieved student, preferably within a period of 15 working days from the date of receipt of the complaint.

- Regulation for grievance may be revise time to time on the directive of UGC and as per Academic Regulation of the University.
- Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson ,within a period of fifteen days from the date of receipt of such decision.

Functions of Ombudsperson:

- The Ombudsperson shall hear appeals from an aggrieved student, only after the student has availed all other remedies provided under these regulations.
- While issues of malpractices in the conduct of examination or in the process of evaluation may be referred to the Ombudsperson, no appeal or application for revaluation or re-totalling of answer sheets from an examination, shall be entertained by the Ombudsperson unless specific irregularity materially affecting the outcome or specific instance of discrimination is indicated.
- The Ombudsperson may avail assistance of any person, as amicus curiae, for hearing complaints of alleged discrimination.
- The Ombudsperson shall make all efforts to resolve the grievances within a period of 30 days of receiving the appeal from the aggrieved student(s)

7. INTERNAL COMPLAINT COMMITTEE

We follow the guidelines prescribed by the University of Mumbai and UGC regularly.

The University has constituted an Internal Complaints Committee (ICC) under the provisions of the UGC (Prevention, Prevention and Control of Violence against Women and College Students) Regulations-2015 and Violence Against Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, Office Order No. 4499 partially modified dated 5 August 2016. This has become obligatory to all the colleges to establish Internal Complaints Committee.

The Committee works to solve problems related to sexual harassment and discrimination in the workplace. As per UGC guidelines, the College has established ICC with the aim of creating a safe and supportive environment for female staff and students and our main objective is to focus on the guidelines laid down by the University Grant Commission for expeditious investigation of complaints outlined in the UGC Regulations-2015 and the Prevention of Sexual Harassment (PoSH) Act.

The Violence Against Women at Work place Act (Defence, Safety and Security) Act, 2013, which replaced the Vishakha Directive of 1997, mandated the establishment of Internal Complaints Committees (ICC) in all Colleges and Universities. To implement these guidelines, the College adopted a Zero-tolerance policy towards sexual harassment.

Our college has established Internal Complaints Committee as per guidelines of UGC to nurture a healthy, secure and supportive environment for female staff and students.

OBJECTIVES

- 1. Attempts made strictly to adhere to the procedures outlined in UGC-Regulations 2015 and the Prevention of Sexual Harassment (PoSH) Act for conducting timely investigations into complaints.
- 2. Implementing guidelines and norms for a campus policy against Harassment.
- 3. Instilling awareness among students and staff about their legal rights under PoSH Act 2013.

PROCEDURE

The Internal Complaints Committee serves as a dedicated body formed by the College to address the complaints. Distinct from the Grievances Redressal Cell, Internal Complaints Committee operates with its own procedures and powers providing a safe and secure environment for employees and students of the College.

The College complaints committee sticks to the procedures prescribed by Sexual Harassment of women workplace Act, 2013 and the College rules to address the complaints.

The procedure includes the submission of the written complaints by aggrieved women to the convener of the committee within prescribed period of the incident. The convener of the committee shall convene a meeting and find out amicable solution and report it to College authorities.

The women's Grievances Rederessal Cell Vishakha is committed to protecting and enhancing the well being of all female employees and students within the organization. Considering the gravity of problem Honourable Supreme Court has issued directives to all the Educational Institutions, Colleges and Universities to establish Sexual Harassment Cell/Committee to safeguard women employees and students from harassment at the work place. The Court has issued mandatory guidelines known as "Vishakha Guidelines" to prevent Harassment at work place. The Cell is dedicated to create a safe environment for the employees.

The Internal Complaints Committee is constituted to prevent the harassment at workplace within the College premises ensuring the policy's implementations through proper reporting and follow up procedures, upholding the commitment of the college to providing congenial environment.

The jurisdiction of Internal Complaints Committee is extended to the entire students and staff engaged with the College. The Jurisdiction also covers the off campus employees on official duties .Penalties be imposed for those found guilty range from a bond of good behaviour to dismissal and the Internal Complaints Committee ensures confidentiality and speedy investigations. The College addresses the seriousness of complaints about sexual harassment and abuse.

Creating conducive environment is essential for gender equality and women's empowerment which is reflected in the action plan of the College. It encompasses various activities related to preventing harassment and promoting gender equality.

- Examination Concessions: Students are entitled to services such as scribes (writers), compensatory extra time to complete papers, and grace marks based on the nature of their disability.
- Assistive Technology: The college leverages its well-equipped computer laboratories to provide digital learning aids.
- Digital Infrastructure: Use of Learning Management Systems (LMS) like Google
 Classroom and Moodle allows for flexible, off-site access to study materials for students with limited mobility.
