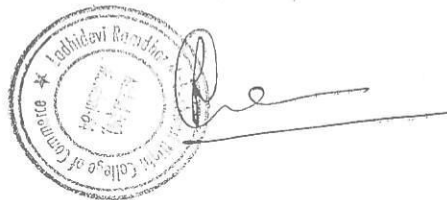

This has reference to your application dated 30/10/2012 requesting permission for affiliation of a new **Night College of B. Com degree course (3 division)** proposed to be started at R.S. Campus, S.V. Road, Malad (W), from the academic year 2013-14.

In this connection, I am directed to inform you that considering the permission granted by the above mentioned authorities to your Trust, I am please to inform you that your Trust has been granted permission for first time affiliation to start new Night College of B. Com degree course (3 division) on the name of R.S. Night College of Commerce proposed to be started at R.S. Campus, S. V. Road, Malad (W), on permanently "**No Grant Basis**" permanently as **Night College** to start B. Com degree course (3 division) with intake of 120 students in each division from the academic year 2013-14.

The college has to fulfill the conditions mentioned in the above referred Government Resolutions and also to fulfill the following affiliation conditions -

- 1) that the conditions laid down by the University from time to time.
- 2) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.
- 3) admissions should not be linked with donations.
- 4) that the college will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4th February, 1987 (copy enclosed).
- 5) that college should follow the norms as prescribed and circulated by the University vide No.CONCOL/75 of 1988, dated 3rd March, 1988 (copy enclosed).
- 6) the college shall not admit the students over and above sanctioned intake.
- 7) the college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.

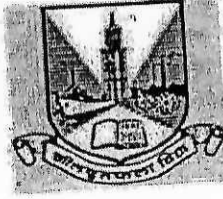
